

# Practical Study Program

## Council Approved (September 10, 2020)

### Student Requirements

The Denturist Society of Saskatchewan has set a minimum number of units to have been completed in a Denturist Technology program at (60 units). If the program falls short of this minimum additional units will be added to the applicable internship. The onus falls upon the student to provide evidence of cases completed in the college setting. Upon graduation a student must apply to the registrar for an intern membership and complete form 3 and pay any prescribed fees. Intern must be aware of limitations of intern membership as outlined in the Regulatory Bylaws **Intern Member 5(1)-(5)**. An Intern member must immediately report any change in employment status. The following are the requirements for intern member:

**One-year internship for any council approved 3-year Denturist Technology program** with a minimum work week of 30 hours per week 1470 hours per year. The following minimum units must be achieved in accordance with the Clinical Protocol as the minimum standard as stated in the introduction section of the current year's Fee Guide:

- Twenty-three (23) cases of complete dentures (i.e. 11 complete upper and lower cases, and one single denture shall equal 23 cases)
- Four (4) case of immediate dentures and attend post insertion care
- Five (5) lab processed relines or rebases
- Six (6) cases of cast frame partial dentures
- Six (6) repairs requiring impressions
- Must obtain the required hours as outlined in continuing education program

**One and half year internship for any council approved 2 1/2-year Denturist Technology program** with a minimum work week of 30 hours per week 1470 hours per year. The following minimum units must be achieved in accordance with the Clinical Protocol as the minimum standard as stated in the introduction section of the current year's Fee Guide:

- Thirty-five (35) cases of complete dentures (i.e. 17 complete upper and lower cases, and one single denture shall equal 35 cases)
- Seven (7) case of immediate dentures and attend post insertion care
- Eight (8) lab processed relines or rebases
- Nine (9) cases of cast frame partial dentures
- Nine (9) repairs requiring impressions
- Must obtain the required hours as outlined in continuing education program

**Two-year internship for any council approved 2-year Denturist Technology program** with a minimum work week of 30 hours per week 1470 hours per year. The following minimum units must be achieved in accordance with the Clinical Protocol as the minimum standard as stated in the introduction section of the current year's Fee Guide:

- Forty-six (46) cases of complete dentures (i.e. 22 complete upper and lower cases, and 2 single dentures shall equal 46 cases)
- Eight (8) case of immediate dentures and attend post insertion care
- Ten (10) lab processed relines or rebases
- Twelve (12) cases of cast frame partial dentures
- Twelve (12) repairs requiring impressions
- Must obtain the required hours as outlined in continuing education program

Recognition of practical study requirements performed outside of Saskatchewan may be considered, on review and approval by council, to be considered to count towards the period of practical study required in Saskatchewan. These hours and cases must be administered through a practical study program by a recognized licensing body in Canada. These cases and hours are only available for transfer within 1 year of completion and with document proof.

**Intern members are responsible to record all clinical procedures performed with patient names or patient number; these records are to be reported quarterly to the Quality Assurance Committee who reserves the right to contact patients to confirm procedures were performed.**
